	The essence of the arrangement defining the joint responsibility in line with Article 26 GDPR is as follows:			
	• The foundation for economic literacy called Stiftung für Wirtschaftsbildung, Am Tabor 36, 1020 Vienna (office@stiftungwirtschaftsbildung.at), serves as the point of contact for issues relating to the protection of personal data and to the rights of data subjects.			
	• Each controller is responsible for complying with the principles set out in Article 5 GDPR with respect to those data it processes.			
	• The controller who is the first to collect personal data is responsible for providing the information referred to in Articles 13, 14 and 26 para 2 sentence 2 GDPR to the data subjects.			
	 Data subjects may assert their rights under the GDPR vis-à-vis the point of contact. If data subjects explicitly assert their rights vis-à- vis one of the controllers, said controller will solely be responsible for responding to the data subjects' requests. 			
	 Requests made vis-à-vis all controllers will be forwarded to all controllers; each controller will then be responsible for complying with the data subjects' request with respect to those data it processes. Requests for access to personal data (Article 15 GDPR) and for data portability (Article 20 GDPR) will be responded to directly by each controller. Requests for the assertion of all other rights, including data subjects' right to withdraw their consent (Article 7 para 3 GDPR), are coordinated and responded to by the controller with whom the data protection requests have been asserted. 			
	• Each controller is responsible for the processors it engages (Article 28 GDPR).			
	• The responsibility for notifying any personal data breach to the Data Protection Authority or the data subjects (Articles 33 and 34 GDPR) lies with the controller responsible for the breach.

6. Information on your rights as a data subject

You have the right to obtain confirmation as to whether or not your personal data, and which of your personal data, are being processed by the OeNB (Article 15 GDPR). You have the right to obtain the rectification of inaccurate personal data or to have incomplete personal data completed (Article 16 GDPR) as long as the rectification and/or completion of the data are necessary for the purpose of the processing operation. You have the right to obtain the erasure of your personal data if the OeNB has processed them unlawfully (Article 17 GDPR). Under certain conditions, you have the right to obtain restriction of the processing of your personal data (Article 18 GDPR). In addition to the right to obtain confirmation, you have the right to receive your personal data, which you have provided to the OeNB, in a structured, commonly used and machine-readable format or to have these data transmitted to another controller where the processing is carried out by automated means and where technically feasible (Article 20 GDPR). Should you consider your right to data protection infringed by any processing of your personal data by the OeNB, you may lodge a complaint with the Austrian Data Protection Authority (DSB) or bring an action before the competent civil court.

7. Right to withdraw consent

You have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal (Article 7 para 3 GDPR).

8. Modalities for exercising your rights as a data subject

Please state in what way your personal data are subject to data processing by the OeNB, specifying the processing activity and outlining the details of your request. Moreover, please provide proof of your identity by enclosing a copy of an official photo identification (e.g. your passport, driver's license, identity card) or using a qualified electronic signature within the meaning of Article 3 item 12 eIDAS Regulation to prevent improper requests by unauthorized third parties that might endanger the protection of your personal data. For the reasons outlined above, such requests must be made in writing.
