Protect the (most) vulnerable




Protect against extreme price increase, but retain motivation for energy savings




Long-term benefits of green policy

Negative impact on economy mitigated by the state support measures through the energy crises in Latvia


Breakdown by years (mill. EUR)




Breakdown by sectors (mill. EUR)




Impact of government energy support on Inflation (percentage points)



Impact of government energy support on GDP (cumulative; deviation %)




