Preface

The quarterly statistical series "Statistiken – Daten & Analysen" published by the OeNB (in German, with English abstracts) since 2004 is supplemented by special issues on selected statistical topics.

This special issue deals with developments in the financial assets and liabilities of the Austrian economy, as reflected by the financial accounts in accordance with ESA 95 (European System of Accounts 95). This publication – the sixth annual financial accounts issue – relates to 2008 and analyzes financial investment and financing behavior in Austria under the changed macroeconomic and financing conditions prevailing in 2008. Section 1 analyzes real economic developments and the financial behavior of the different economic sectors in the crisis year 2008; the set of tables and indicators in section 2 detail asset and liability stocks and the underlying investment and financing transactions for each sector of the domestic economy and for the rest of the world (in relation to the domestic sector). These statistics reflect how the individual sectors of the economy interact financially through the financing instruments they use, and they serve as the basis for the establishment of key metrics, such as net lending/borrowing, gross and net borrowing and debt-equity ratios.

I. Financial Investment and Financing Developments in Austria in 2008¹

1 Economic Background

According to calculations by Statistics Austria, Austrian GDP grew by 4.1% or EUR 11.1 to EUR 281.9 billion in 2008, which comes to EUR 33,810 per resident and represents a real-term rise by 2.0%. After augmenting powerfully in real terms in 2006 and 2007 (by 3.5% in each year), GDP growth slowed markedly in 2008, given the difficult global economic conditions. Nevertheless, the increase in value added in Austria was higher than the euro area average.

Consumption reached EUR 201.4 billion in Austria in 2008, with households accounting for EUR 148.8 billion of this amount, whereas gross capital formation came to EUR 64 billion, with nonfinancial corporations accounting for EUR 43.8 billion. At current prices, consumption rose by 4.2% (by 1.4% in real terms). Gross capital formation went up by 3.3% in nominal terms and by 0.3% in real terms from 2007. Net investment in the real economy ran to EUR 21.1 billion, which is up by 3.4% on 2007. Nonfinancial corporations accounted for EUR 15.7 billion of this amount, households for EUR 6 billion. Excluding consumption of fixed capital, the investment-to-GDP ratio came to 11.6%; the gross ratio was 29.5%. In 2008, net national disposable income gained 4.4% to EUR 232.6 billion, with EUR 168.8 billion household disposable income making the largest contribution both to the increase in levels and to growth. The compensation of employees advanced

The Austrian economy's net worth – made up of the internal funding components savings and net capital transfers excluding consumption of fixed capital – amounted to EUR 31.3 billion, a 6.1% rise on 2007. The household sector predominated this development, having recorded net worth of EUR 21.6 billion in 2008. The saving ratio² edged up to 12% from 11.3% in 2007, whereas the profit ratio³ (net, excluding consumption of fixed capital) of nonfinancial corporations amounted to 37.6% in 2008, down by 1.4 percentage points against the 2007 value.

According to the data provided by Statistics Austria under the Excessive Deficit Procedure (EDP) notification, government revenue came to EUR 136,5 billion in 2008 (+4.7%); government expenditure was EUR 137.9 billion (+4.3%). Government revenue as a share of GDP was thus equivalent to 48.4%; the corresponding government expenditure ratio was 48.9%. The general government deficit amounted to -0.5% of GDP, the Maastricht deficit to -0.4% of GDP.

As in 2006 and 2007, the Austrian financial accounts exhibited net lending in 2008 as a result of net financing by the financial and household sectors and net borrowing by the corporate and government sectors. Net financing to the rest of the world totaled 2.9% of GDP.

Consumer prices as measured by the HICP advanced by 3.2% in 2008,

more than 1 percentage point more than in 2007, but in November and December 2008, inflation slowed noticeably. The trend continued in 2009.

The unemployment rate (as defined by Eurostat) stood at 3.9% in 2008, following 4.4% in 2007. The decline in unemployment continued until summer 2008 came to a halt in the second half, when unemployment figures began to rise, a trend which continued through the first half of 2009. Unemployment reached 2007 levels at end-June 2009.

According to the consumer confidence survey⁴ conducted by GfK Austria, consumers considered that their financial situation deteriorated in 2008 compared to the previous year. Confidence was particularly affected during the height of the financial crisis in the fourth quarter of 2008.

2 Interest Rates; Equity and Bond Prices

Until July 2008, the euro area key interest rate climbed to 4.25%; from the beginning of October 2008, it diminished steadily. In September 2009, the key interest rate stood at 1%. In the wake of this decrease, retail interest rates on domestic banks' new deposits and new loans fell as well. In December 2008, interest rates on deposits with an agreed maturity of up to one year ran to 3.55% (December 2007: 4.28%) for households and to 3.02% (December 2007: 4.60%) for nonfinancial corporations. Austrian banks' interest rates for new loans also dropped, in some cases more gradually, though. Interest rates on consumer loans eased from 6.56% in December 2007 to 6.42% in December 2008, those on housing loans changed from 5.27% to 5.39%.

In the same period, interest charged on loans of more than EUR 1 million to corporates sank from 5.09% to 4.51%.

The secondary market yield on Austrian government bonds stood at 4.21% in December 2007 and declined to 3.41% in December 2008. The average price of all Austrian government bonds rose from 98.77 in December 2007 to 104.17 in December 2008.

The Austrian stock market, too, was hit by developments in international financial markets. On December 31, 2008, the ATX closed at 1,750.83, down by 61.2% on the 2007 value.


The average dividend yield in 2008 was 2.28% in 2008, which compares to 1.91% in 2007.

3 Financial Investment and Financing Developments in Austria

Austria's financial investment attained a volume of EUR 266 billion in 2008 (compared with EUR 204 billion in 2007), nearly equaling Austrian value added. Financing amounted to EUR 258 billion (2007: EUR 195 billion). Consequently, Austria's net lending totaled some EUR 8 billion. Financial investment and financing expanded not just in absolute terms, but also as a share of GDP. Currency, deposit and loan financing flows predominated both financial investment and financing at EUR 211 billion and EUR 189 billion, respectively. Volumes of these financing instruments burgeoned to more than double their 2007 levels. Mirroring capital market developments, transactions with tradable securities – debt securities, quoted shares and mutual fund shares – represented an important complement to nonsecuritized financial investment from 2004




Financial Transactions of All Economic Sectors by Financial Instruments

through 2007 for the financial sector and for households, but when the financial crisis exacerbated in 2008, the transaction volumes of these instruments plummeted. Debt securities remained a major source of financing for the government and banks alike.

Broken down by economic sectors, banks, including the Oesterreichische Nationalbank (OeNB), predominated the level of financial flows. In 2008, financing flows between banks and the OeNB were especially large. Conversely, capital movements between other financial institutions excluding insurance corporations and pension funds preponderated among financing flows between 2004 and 2007, in particular because of the activities of mutual funds, but also those of banks' financing and holding companies. However, due to the financial crises, this sector's activities diminished considerably in 2008. The household sector, above all consumers, with their continuously high financial investment of some 7% to 8% of GDP contributed importantly to the net financing of other domestic sectors and the rest of the world. The development of financial investment in the past 28 years correlates very strongly with household savings.

The total economy's financial assets amounted to EUR 2,364 billion at end-2008, which corresponds to 838% of GDP, whereas financial liabilities came to EUR 2,383 billion on the same date (845% of GDP). Thus Austria has net liabilities to the rest of the world totaling about EUR 19 billion or 7% of GDP. The net change in financial investment in 2008 came to EUR 164 billion or 7.4% of the holdings at end-2007, so it was clearly below the value of financial investment itself. Transaction-related growth in financial assets ran to 12.1% in 2008. Liabilities expanded by EUR 159 billion in 2008, e.g. by 7.1% of total liabilities at end-2007, whereas the growth rate of liabilities due to financing transactions came to 12.3% in 2008. The key reason for the discrepancy between net changes and transaction-related growth of stocks was the development of mar-

ket prices (including exchange rate changes) of domestic investors' securities holdings. In 2008, the market value of the securities portfolio of all Austrian investors diminished by EUR 88 billion as a result of price losses. The household sector was affected most strongly, as its holdings of securities lost EUR 24 billion or 21% of their value in 2008 on end-2007 levels.

A breakdown of financial assets by instruments at the end of 2008 provides information about the development of both capital movements and market prices in 2008: Roughly 54% of financial assets and 51% of financial liabilities in the Austrian economy consisted of currency, deposits and loans. Shares of these instruments were last this high in 2002 and 2003. Holdings of tradable securities at market prices accounted for 24% of total financial assets and 28% of total financial liabilities. These shares were as low as in 1998.

Austria's net financial position by economic sectors shows both nonfinancial corporations (EUR 220 billion or 78% of GDP) and the general government EUR 92 billion or 33% of GDP) were net borrowers; the household sector was a net lender (EUR 301 billion or 106% of GDP). Bank products accounted for EUR 256 billion or 56% of the household sector's total financial investment of EUR 449 billion. This makes the household sector the thirdmost important investor for banks following banks themselves and the rest of the world. Bank loans of EUR 126 billion accounted for the lion's share of the household sector's liabilities of EUR 149 billion at end-2008.

III. Methods, Definitions and Sources of the Financial Accounts

3.1 Methods

The financial accounts for Austria are compiled in accordance with the rules of the European System of Accounts 1995 (ESA 95). and records both stocks (financial assets held and liabilities outstanding at the end of every reporting year) and flows (financial investment and financing transactions undertaken during the year). Acquisitions less disposals of financial assets (financial investment) are cross-tabulated with the incurrence of financial liabilities less their repayment (financing). The balancing item, net borrowing or net lending, is the result of the sequence of accounts of both the financial investment and the financing sides of the financial accounts.

3.2 Definitions

Financial assets: The financial assets of domestic residents comprise the financial claims of a given institutional sector of the domestic economy on both resident and nonresident borrowers; conversely, the financial assets of the rest of the world comprise the financial claims of nonresidents on resident borrowers.

Liabilities: The liabilities of domestic residents comprise the financial liabilities of a given institutional sector of the domestic economy against both resident and nonresident lenders; conversely, the financial liabilities of the rest of the world comprise the financial liabilities (excluding monetary gold and SDR) of nonresidents against resident lenders. Total economy (domestic residents): The total economy is composed of all the individual institutional sectors of the domestic economy, namely nonfinancial corporations, financial corporations, general government and households (including nonprofit institutions serving households – NPISHs).

Nonfinancial corporations: Corporations and partnerships which are principally engaged in producing goods and nonfinancial services.

Financial sector (financial corporations): MFIs, other financial institutions/financial auxiliaries, insurance corporations and pension funds.

Monetary financial institutions (MFIs): The OeNB and other MFIs (banks according to the ECB's definition of MFIs for statistical purposes).

Other financial institutions except insurance corporations and pension funds: Banks which do not qualify as MFIs, financial holding companies, financial umbrella companies, pension-fund and investment-fund management firms.

Insurance corporations and pension funds: Insurance corporations which are not classified in the social security sector and (single-employer and multiemployer) pension funds.

General government: Central government, regional governments, local governments, social security funds as well as public trade associations and organizations.

Central government: All institutional units classified as part of the federal government sector. This includes the Austrian Federal Financing Agency, universities, funds at the federal government level (such as the ERP fund) and federal trade associations.

Households: Individuals and self-employed persons as well as single proprietorships.

Nonprofit institutions serving households (NPIHs): Nonprofit institutions with a

separate legal personality which are other nonmarket producers and serve households (in Austria, e.g. trade unions, churches and private foundations). Since the reporting year 2006, securities investment by private foundations have been covered by this item.

Monetary gold and Special Drawing Rights (SDR): Gold held as a component of reserve assets and SDR created by the IMF.

Currency and deposits: Banknotes, base metal coins, bimetallic coins, silver coins, transferable deposits with banks (personal checking accounts, sight deposits), time deposits, saving deposits and cash pooling accounts. Since the reporting date December 31, 2002, schilling-denominated banknotes and coins have been recorded under "other accounts receivable" instead of under currency. Stocks are recorded at their nominal value.

Securities (other than shares) and financial derivatives: Money market instruments (securities with an original maturity of up to one year), capital market instruments (securities with an original maturity of more than one year) as well as financial derivatives based on both interest rate and capital contracts. The securities transactions and the resulting securities portfolios include any interest accrued and not yet paid in line with the accruals principle applicable under the ESA 95 framework. Stocks are valued at current market prices.

Loans: Unsecuritized, interest bearing debt. This includes loans extended by financial corporations, associated companies and government entities, particularly under the central government's intermediary funding programs and the home loan programs of the regional governments (including the city of Vienna), but excludes trade credits. Loans are valued at nominal prices or book values.

Quoted shares: Corporate shares listed on a stock exchange or traded on other markets. Valuation is at market prices.

Other equity including unquoted shares: Unquoted shares, shares in domestic limited liability companies or shares in foreign corporations, as well as crossborder holdings of real estate (in line with ESA methodology). Unquoted shares are valued at equity book values. The value of real estate holdings is based on cumulated value of transactions conducted since 1995.

Mutual fund shares: Shares in corporations either traded on a stock exchange (closed-end funds) or subject to issuance and withdrawal by a corporation (open funds). Valuation is at market prices.

Insurance technical reserves: Net equity of households in life insurance and pension fund reserves; claims of households and nonfinancial corporations related to prepayments of insurance premiums and reserves for outstanding claims. Valuation is at book values.

Other accounts receivable/payable: Claims or liabilities arising from trade credits and advances as well as all financial assets and liabilities not classified in another category. Since the reporting date December 31, 2002, this item has also included schillingdenominated banknotes and coins.

3.3 Sources

OeNB balance sheet data, money and banking statistics of domestic MFIs, monthly reports of banks resident in Austria, assets under mutual fund management, quarterly and annual financial statements of insurance corporations and pension funds (annual data for pension funds from the Financial Market Authority). Assets and liabilities of the government sector based on data of the Austrian Federal Financing Agency and Statistics Austria; annual data from the balance of payments, the international investment position, security-by-security statistics based on reports by depositories resident in Austria, reports on own-account holdings of resident investors as well as securities identification information, the statistics on stock corporations compiled by Statistics Austria as well as balance sheet data from a commercial database for limited liability companies in combination with Company Register data. OeNB calculations (above all of cash holdings of nonfinancial corporations, households including NPISHs as well as of the rest of the world).
